

The Steering Committee decided on the following:

1. To adopt and approve the fourth interim quarterly report as a base. Within 2 (two) weeks submit the proposals in writing on Quarterly report No4 and make amendments to the fourth quarterly report and submit it to Members of the Steering Committee for harmonization and to Delegation of the European Union to the Republic of Azerbaijan.

- 2. During the development of the legislation in relation to the funded component in the multi-level state pension system and drafting of legislation to facilitate and regulate private, voluntary, pension arrangements, the necessity was emphasized to involve a national lawyer from the SSPF whose role would be crucial in drafting the Azerbaijani legal language and bringing it in line with international legislation standards.
- 3. To work hand in hand with the beneficiary side in the actual legislation drafting process and improve communication to avoid any confusion in the future and produce efficient results.
- 4. All suggestions and any comments from both sides have to be submitted in written form.
- 5. To urge a free and unlimited access to internal documents of SSPF which continues to cause barriers in implementing the project activity on the analysis of management processes at SSPF.
- 6. SSPF will submit its written comments about the completed blueprints of funded component and establishment non-state pension institutions and development of legal framework in Azerbaijan.
- 7. Discussion about the project extension until November, 2015. Project extension has to be made according to addendum in view of activities and finances.
- 8. The next Steering Committee meeting shall be held at the premises of the State Social Protection Fund on 30th of July, 2015, at 10:00.
